The accused nos. (1) to (8) and other four unknown persons as a part of pre-planned conspiracy, formed unlawful assembly and in order to achieve their common goal, when the complainant and witness Abid Zaikir Shaikh after performing Namaz on the occasion of Bakri eid were returning home on their Honda Moped No.GJ-19-AS-4961 at that time the present accused persons who were travelling on motorbike carrying iron pipes in their hands, on seeing the complainant and the witness, tried to stop them. The complainant and witness did not stop their moped. The accused kicked and pushed them down and abused them. With an intention to kill, the accused hit the complainant and witness with iron pipes causing grievous hurt on the body of complainant and on liver and left leg and hand of the witness. On arrival of the police force, the accused escaped and ran away.

My name is Nadim Ibrahim sheikh, aged about 24 years, occupation service, resident of village Tarsadi Near Pachal complex, Taluka Mangrol, district Surat. Phone No. 8128973836.

On being personally asked at Trauma centre of New Civil Hospital, Surat, I am narrating this complaint. I am residing at above address with my family. I am working for marketing of paan masala near Delhi gate at Surat and earning my livelihood. My father's name is Ibrahimbai and mother's name is Hinaben. My parents have four brothers and sisters. The name of my maternal uncle's son is Abid Zakirbai Shaikh who is working in a shop for selling clothes at Surat.

On about 20th June at about 10 to 11 pm I was standing near Torva Mazjid at Surat railway station. At that time Bilal Ghulam Rasul Kagzi, occupation Advocate, aged about 35 to 40 years, resident of Kosamba, behind government hospital threatened m- "I am Advocate. Nobody can harm me. But, you do not come to Kosamba, else I will kill you. I will break the limbs of your father who is driving autorickshaw". Thereafter, I left the place and went to my maternal uncle's house at Bhestan. Considering incident to be very trivial, I did not inform anyone and I did not lodge any police complaint. Since I did not find it serious, I took the incident very lightly.

Before 20 days from today my father namely Lukman Ibrahim Shaikh, aged about 45 years, occupation autorickshaw driving while he was at autorickshaw stand opposite Shailesh Sales, Kosamba, Akram Saiyed (brother of Jalil Saiyed) threatened him- "Do not live with your son in Kosamba, else he will be killed. If you want to do business, do it alone. Do not keep your son with you". This was informed to me by my father. However, we did not lodge any police complaint. Since I did not find the incident to be serious, I took it very lightly.

Thereafter today 12/08/2019 being the festival of Bakri Eid, I had holiday and therefore I was present at home since morning. At about 8 O'clock in the morning, I was returning home along with my maternal uncle's son Abid Zakir Shaikh, resident of Tarsadi village, near Panchal complex, Taluka Mangrol, District Surat after performing namaz in the Masjid at old Kosamba village in Honda Moped No.GJ-19-AS-4961. At that time around 8.30 am while we were moving on moped down the bridge of Varda village, the resident of Kosamba namely Zahir Jamil Saiyad, Zakir Jamil Saiyad, Bilal Ghulam Rasul Kagzi, sohel Akram Saiyad, Sohel Saukat Pathal alias Bhaylo, Shahnawas alias Saddam Jalil Saiyad, Jalil Abdulla Saiyed, Zamir alias Lalul Jalil Saiyad and four other persons whose names and addresses are not known to me but I can recognize their face, all these persons came on motorbike with iron pipes in their hands. I was driving moped. They tried to stop me. I did not stop the moped. While my moped was in motion, Zakir Jamil Saiyed kicked me and pushed me down from moped. I and Abid Zakir Shaikh fell on the ground.

Thereafter aforesaid persons who came on motorbike abused me in filthy language. They said they would kill me today. "Today is your last Eid" they said and then with an intention to kill, Zahir Jamil Saiyad hit me on forehead with iron pipe. I was injured. Thereafter some other person hit me with iron pipe on my head from back. Other persons started hitting me on my head from all sides.

The son of my maternal uncle Abid Zakir Shaikh also fell down from moped. The aforesaid persons beat him up with iron pipes. His liver was injured. He is

undergoing treatment as indoor patient in civil hospital at Surat. His left leg has been stitched with four stitches. He has received serious injuries on fingers.

While the attack on us was going on, a police vehicle arrived and we were saved from deadly attack. On seeing the police force on vehicle, the aforesaid persons fled away on their motorbikes, leaving iron pipes at the spot.

In the aforesaid attack my moped and mobile were damaged. The policemen have taken us for first aid treatment at RF Hospital, Kosamba. After primary treatment at RF Hospital we have on our own volition gone to civil hospital at Surat for further treatment. My treatment is going on. I am in sound state of mind.

The original cause of attack on us by the aforesaid persons is the old and ongoing enmity between us for which we have been attacked.

Therefore, my complaint is for legal action against (1) Zahir Jamil Saiyad (2) Zakir Jamil Saiyad (3) Bilal Ghulam Rasul Kagzi (4) Sohel Akram Saiyad (5) Sohel Saukat Pathan Alias Bhaylo (6) Shahnawaz Alias Saddam Jalil Saiyad (7) Jalil Abdulla Saiyad (8) Zamir Alias Lalu and other four persons whose names and address are not known all residents of Kosamba Tal: Mangrol Dist.Surat. My witnesses are named in the complaint and other persons found during investigation.

The facts stated in my complaint are true and correct as per my dictation.
